Rules of Use of Certification Mark and Logo

Rules for use of Certification Mark and Logo

Rules governing use of Certificate (product certification and Accreditation Mark)

Lox agency issues marks corresponding to the relevant product for which approval has been given, by way of a current Certificate of Registration. The certification mark (Product conformity) used must correspond to the standard/scheme against which the product or manufacturer has been evaluated and achieved registration

NOTE: Any misuse of marks may result in withdrawal of certificates.

To ensure that the correct markings are used, the following rules shall be observed by all companies who receive product certification through Lox agency:

- The marks shall be displayed only in the appropriate form, size and colour, and in their entirety, including frames
- Logos may only be represented in their intended colours or in black and white;
- Its not allowed to use the marks out of the determined/certified scope, such as on their laboratory reports, different products.
- If a client after withdrawal or resignation of a certificate keeps using logos or other expressions that give rise to the suggestion that certification is still valid, Lox agency may take legal action;
- Lox agency expressly reserves the right to publish any unlawful use of its logos and certificates;
- Lox agency will take suitable action, at the expense of the client, to deal with incorrect, unlawful or misleading references to certification or use of certificates and certification marks. These may include legal action and/or publication of the transgression. Incorrect, unlawful or misleading use of such a mark or logo is considered a critical non-conformity with certification requirements and will most likely result in immediate suspension of certification.
- The products certificate number is printed under the mark.
- Electronic reproduction of the marks is permitted to manufacturers certified by lox agency (including Internet websites) provided that the requirements are met and
 - The manufacturer's certificate number is printed under the mark
 - The mark is reproduced so that infilling does not occur
 - Degradation and/or distortion of the mark graphic is avoided
 - Computer files of the marks shall be prepared from mark masters. Redrawn approximations may not be used.
- Product conformity marks / logo shall not be used in any way that might mislead the reader about the status of a certified manufacturer, activities outside the scope and imply that

product is certified. Holders of Certificate shall not make, use or permit any misleading statement and certification document.

- Holders of certificates should not use its certification in such a manner that would bring the certification body and / or system into disrepute and loose public trust.

Lox agency will take action and deal with incorrect references to certification status or misleading use of certification documents, marks. The action may include requests for correction and corrective action, suspension, withdrawal of certification, publication of the transgression and if necessary legal action.
